*Mrs. Mihok asked that in the October* 28, 2009 *minutes page* 3 *of* 11 *bottom of page the word "misinformation" be in quotations to reflect that this is Mrs. Reithmeyer's word.* 

*Mrs.* Mihok stated that motion 2.1 on page 4 of 11 "Concerning the last paragraph on page 3 beginning Mr. Kemp and Mrs. Reithmeyer tried to delay the defeasance . . . – Mrs. Reithmeyer commented that this is Mr. Hellmann's opinion." -- I have copies of the January 23 minutes from 2008 page k which states:

### "The Board defeated a motion to TABLE item 5.4.1.

Motion to table moved by Mr. Kemp; seconded by Mr. Frankenfield; defeated by a vote of 5 nays; 3 ayes. Members voting aye were Messrs. Kemp and Frankenfield, Mrs. Reithmeyer".

At that time, it was defeated by a motion of 3 for; 5 against tabling it. This was followed by  $\frac{3}{4}$  of a page of discussion. Therefore, this was definitely not your opinion, Mr. Hellmann; these were the facts as they were stated January 23, 2008 and as they appear in the minutes that reflect those statements. So I ask that this be included in the minutes.

*Mr.* Hellmann stated --- "It is not my opinion, it is a fact Kemp and Reithmeyer tried to delay the defeasance of our expensive debt. On January 23, 2008 Kemp and Reithmeyer voted to table motion 5.4.1 which was to take steps to defease a substantial portion of the 2006 General Obligation Debt. The tabling motion was defeated 5-3. If the debt defeasance was delayed until the next business meeting in February, 2008, it would have cost an approximate extra \$665,000 to defease the debt in March, 2008 due to declining interest rates."

"This town can not afford incompetence on our school board. People's homes are at risk And our children's education is at risk because the more money you waste, the less money for education. Let's put this to bed and move on".
